- Videographer reserves the right to cancel or reschedule engagement in the event of catastrophic accident, illness, transportation problems, or other unforeseen difficulties, which could arise as an "Act of God."
- Final video length is dependent upon duration of ceremony, speeches and various traditions at event.
- Average turn around time is 1-4 months depending on package and time of year of event.
- If videographer does not arrive as scheduled you are entitled to refund of deposit.

However, in the event of equipment or other failures, should Documented Video Productions fail to comply with this contract, Documented Video Productions is only limited to a refund of deposits.
- Additional edits upon request can be made, however additional charges may incur.
- Duplication of this video is prohibited. All copies are to be made by Documented Video Productions.
- Videographer will make every effort to ensure a smooth, timely, and enjoyable engagement.



## **GENERAL TERMS AND CONDITIONS**

**GENERAL TERMS:** In exchange for the indicated fee, Documented Video, The Producer, agrees to produce a DVD for the client, as signed below. Client engages the Producer to make a DVD for private home use. DVD is a copyright of Documented Video; Camera original and master files and materials remain the property of Producer. Broadcasting, cablecasting, webcasting or any use of the DVD that may result in revenue or wide distribution requires Producers written approval. Unauthorized copying is prohibited.

**RESERVATION FEE, PAYMENTS, and CANCELLATION:** A signed contract and non-refundable reservation fee are required to reserve the specified coverage. Upon receipt of this fee and contract, the Producer shall reserve the date, time and production personnel. Client agrees to make all specified payments in a timely manner. In the event of postponement or cancellation of this contract the reservation fee is non-refundable.

**MATERIALS AND EQUIPMENT:** Producer takes the utmost care to insure the materials and equipment used will operate to your satisfaction. However, in the event that the Producer fails to comply with the terms of this contract due to any event or act outside of the control of Producer, the liability is limited to the refund of the reservation fee paid.

**CLIENT RESPONSIBILITY:** The client hereby assumes responsibility for his/her guests and agrees to maintain conditions that will not inhibit the performance of the Producer, nor cause injury, loss or damage to the crew or their equipment.

**MEALS:** Producer suggests that CLIENT will provide the same meal offered to any other vendor served during the event.

**CLIENT- FURNISHED MATERIALS:** Photographs, artwork, videotapes, DVD's, recordings, or other Client-furnished materials are due on or before the event date. Failure to comply will be subject to additional editing rates of seventy-five (\$75) per half hour of time to re-edit video to include these materials. Although Producer takes utmost care with these materials, Producer's responsibility for lost or damaged materials extends only to the cost of raw stock and processing.

**RIGHTS TO INCLUDED MATERIAL:** Client warrants that he/she has the legal rights to anything Producer will videotape including live action, voices, photographs, audiotapes, CDs, DVD's, videotapes, or any other elements delivered to Producer for inclusion in the production. Client shall indemnify and hold Producer harmless for any loss, damage, or liability for any infringement of any rights arising from the viewing use or sale of DVDs that Client hires Producer to produce, edit, or duplicate.

**EDITING:** Original material will be edited at Producer's artistic discretion. Any requested stylistic changes shall be considered Additional Editing subject to additional editing rates of \$75 per half hour of time to re-edit video. Technical adjustments, misspellings of names or titles, video or audio glitches, will be corrected at no charge.

**COMPLETION AND PAYMENT FOR SERVICES:** The DVD will be completed approximately ten - twelve (10-12) weeks after the event. Actual completion time may vary based on seasonal workload, specific requirements of the assignment, or unforeseen circumstances affecting the editing. No DVD, either in progress or completed, may be taken from the office or studio unless all balances are paid in full. A service charge of \$35.00 will be charged for any dishonored checks. In the event client fails to pick up DVD and pay balance due within fifteen (15) days of notification of DVD completion, then a late penalty shall be assessed in the amount of ten dollars (\$10.00) per week until payment is made.

**ACCEPTANCE OF DVD:** Client shall view the completed DVD **within One Week** of delivery and advise Producer of any TECHNICAL ADJUSTMENTS or ADDITIONAL EDITING changes required by client. If the Producer is not contacted by client **within One Week** of receipt of the completed DVD, the DVD shall be deemed accepted as received by client with all claims waived.

**DEFAULT BY CLIENT:** In the event of default by client of any provision of this agreement, client agrees to pay all costs of collection, interest at the rate of one and one half (1.5) percent per month or eighteen (18) percent per annum from the date of default and Producer's reasonable attorney's fees.

**BINDING AGREEMENT:** Client acknowledges that signing this document he/she has entered into a binding agreement with Documented Video and that any dispute between the parties shall be governed by the laws of the State of Maryland.
